Parents can now order textbooks for their children with the Edu DynamiX app and make payments via Tap & Go, circumventing the need to visit physical bookstores. For even greater convenience, textbooks are delivered directly to schools for pickup by students. The Edu DynamiX app is developed by Active Learning Solutions Ltd.
