Smart Charge launches new ceiling-mounted charging solution for half the installation fee and convenient maintenance

HONG KONG, 13 March 2023 – Smart Charge (HK) Limited (Smart Charge), co-established by HKT Limited (HKT) and CLP Holdings Limited (CLP), announces the launch of a new ceiling-mounted charging solution*, aimed at solving the problems of high cost, large size, complex maintenance, and the need for stable mobile network support associated with old ceiling-mounted chargers. Electric vehicle (EV) owners can install the new ceiling-mounted charger at an island parking bay, with no adjacent walls or columns, for close to half the cost^ to enjoy a safe and reliable charging experience, promoting the adoption of new energy transport in Hong Kong.



Smart Charge's new ceiling-mounted charger features:

- **A weight reduction of over 80% compared to its predecessor:** Compared to the previous model, the weight of Smart Charge's new ceiling-mounted charger is reduced by more than 80%, cutting the installation fee by nearly half and significantly increasing the adoption appeal for EV owners while helping to lessen property management's concern over the weight of EV chargers.
- **RFID technology eliminates smartphone connection issues:** Smart Charge's new ceiling-mounted charger utilises RFID technology, which instantly detects the vehicle once it is parked and activates the system. EV owners can easily charge their vehicle by simply connecting the power cord to their car, eliminating the need for smartphone activation used in previous model, thereby avoiding the issue of unstable network signal in many car parks.
- **Convenient installation and maintenance:** Some EV owners might consider pillar chargers for their island parking bay, which often involves groundwork to bury the necessary cords, making them more complex to install and maintain.
- **Professional certification for reliable safety:** The new ceiling-mounted charger is researched and developed by Smart Charge. On top of being certified by structural engineers, the height of its cable can also be adjusted to suit the needs of the EV owner for a safe, reliable and convenient charging experience.

Currently, Smart Charge serves 33 of Hong Kong's major housing estates, covering about 10,000 parking bays, about 30-40% of which are island bays. Smart Charge will continue to explore the needs of EV owners and strive to provide dependable, solid and reasonably priced EV charging services.
