Where there are joint registered holders of any share of the Company, any one of such persons may vote at the AGM, either personally or by proxy, in respect of such share as if he were solely entitled thereto; but if more than one of such joint holders are present at the AGM personally or by proxy, one of the holders so present whose name stands first on the register of members of the Company in respect of such share shall alone be entitled to vote in respect thereof.

 The instrument appointing a proxy and the power of attorney or authority, if any, under which it is signed (or a notarially certified copy of that power of attorney or authority) must be deposited with the share registrar of the Company, Computershare Hong Kong Investor Services Limited, Investor Communications Centre, 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong no later than 48 hours before the time appointed for holding the AGM at which the person named in such instrument proposes to vote, and otherwise the instrument appointing a proxy shall not be treated as valid. In calculating the period mentioned for depositing the instrument appointing a proxy, no account is to be taken of any part of a day that is a public holiday.
- Delivery of an instrument appointing a proxy shall not preclude a shareholder from attending and voting in person at the AGM or poll concerned and, in such event, the instrument appointing a proxy shall be deemed to be revoked.
