to support UnionPay QR codes in mainland China and worldwide**

Starting today, designated Tap & Go users² can use the Tap & Go app to scan UnionPay QR codes at merchants or display their own QR code on the app at merchants that support QR code for payment in mainland China and across the world without additional procedures.
